

Michigan's 1970 Environmental Protection Act, passed by the Michigan Legislature and signed by Governor Milliken, included wording, giving anyone the right to sue over damage to the state's water, air or land. On July 25, Michigan's Supreme Court struck down that provision saying only those who can prove they were directly harmed have a right to sue. In a 4-3 decision, the court's ruling came in response to a lawsuit filed by environmentalists claiming a Mecosta County water bottling plant operated by Nestle Waters North America threatened to lower the levels of two nearby lakes, a stream and three wetlands. The court said they lacked legal standing to sue for damage to those waterways where they did not reside or own property.



Indiana is grappling with the balancing act of weighing the value of jobs and economic development with the environmental impact of industrial discharges to Lake Michigan. British Petroleum seeks to expand its Whiting, IN refinery at a cost of \$3.8 billion. Industrial discharge levels are set by USEPA by a formula pegged to production. Whiting's permit by Indiana Department of Environmental Management, increases discharge levels by up to 1,500lbs. ammonia and 5,000lbs. sludge daily into Lake Michigan. With additional permit reviews under way for other IN industrial plants, LWV IN has been called to give testimony.

GLOBAL CLIMATE CHANGE

Falling water levels in the Great Lakes Basin are having serious economic and health impacts. The electricity industry is second only to agriculture as the largest user of water in the US. Electricity production from fossil fuels and nuclear energy requires 190,000 million gallons of water per day, accounting for 39% of all freshwater withdrawals in the nation, with 71% of that going to fossil-fuel electricity generation alone. Warnings were issued concerning how rising temperatures will result in changing weather patterns; increased extremes of weather events; increased forest fires; movement of insects, fungus and mold spores further north to areas with little or no resistance; the possible extinction of 20-30% of species.

BIOMASS FUEL PRODUCTION

Is this a trade off between sustainable energy and sustainable water resources? The choice between fuels, method of transportation and power production is by no means black and white. Great Lakes shipping and ballast issues are interconnected.

PARTNERSHIP BUILDING, BASIN-WIDE and INTERNATIONAL

We see a 'rising tide' of public awareness of the true economic impact of environmental degradation. 180 representatives of US and Canadian cities large and small, non profit organizations, US and Canadian state and federal representatives -

all focused on establishing resolutions and goals to restore and protect the future of the Great Lakes ecosystem.
